

**PLEASE TAKE NOTICE OF A NEW BYLAW TO REGULATE AND CONTROL THE WATER AND
SEWER SYSTEM IN THE TOWN OF VONDA.**

TOWN OF VONDA

BYLAW NO. 07-2024

A Bylaw to Regulate and Control the Water and Sewer System

The Council of the Town of Vonda in the Province of Saskatchewan enacts as follows:

- 1. This bylaw shall be known as the Water and Sewer Management Bylaw.**
- 2. In this bylaw:**
 - a) "Town " means Town of Vonda**
 - b) "Administrator" means the Town Administrator for the Town of Vonda**
 - c) "Consumer" means and individual(s) or corporation that has, or wishes to have a water/and or sewer service connection.**
- 3. Connection Fee**

A \$75.00 connection fee shall be paid to the Town each time a consumer wants to be supplied with water from the municipal system.
- 4. Disconnection Fee**

A \$75.00 disconnection fee shall be paid to the Town each time a consumer wants to be disconnected from the municipal water system.
- 5. Installation of Water Meters**
 - a) Tamper Proof Water meters shall be installed in every business and corporation in the Town of Vonda.**
 - b) Water meters shall remain the property of the municipality.**
 - c) The owner of the property being serviced shall provide a frost-proof location for the water meter that is readily accessible for the purpose of taking water meter readings.**
 - d) The owner of the property being serviced shall be liable for the full replacement cost of the meter installed on his property if damaged by frost or other cause.**
 - e) Consumers shall allow Town employees free access at proper hours of the day and upon reasonable request made, to all parts of the premises in which water is delivered, for the purpose of inspections or repairing any service pipe**

or for the placing of meter they deem expedient and for the purpose of protection or regulating the use of any meter.

6. Only Town employees or persons under the direction of the Vonda Fire Department shall open, close or interfere with any hydrant, valve or curb stop connected with the water works system.
7. Water rationing
 - a) The Town shall have the right to limit the amount of water furnished to any or all consumers should circumstances warrant such action.
8. Water Distribution
 - a) No resident or business may distribute, re-sell, or supply water for the use or benefit of others.
9. Where a consumer owns the property served and any rates or charges in arrears remain unpaid 60 days after the billing date, that amount can be added to and thereby form part of the taxes on the land or building(s) with respect to which the service was provided.
10. Any person who contravenes any provision of this bylaw shall be guilty of an offense and liable upon summary conviction to a fine of \$2000.00 and costs for every offence.
11. Any Corporation or Business who contravenes any provision of this bylaw shall be guilty of an offense and liable upon summary conviction to a fine of \$5000.00 and costs for every offence.
